To keep the prices low, each group will need to provide their own table and, if desired, an awning. You will choose a 10' x 10' space on the grass in the park, first come first served on choosing a location on the morning of the fair.

Reserve your space! Print and fill out form, and mail it in with your check. As costs include park fees, sound system and insurance, we welcome any donations beyond these amounts.

Sponsors

Registration before July 7 to be on the posters, but we take sponsor registration forms until August 25. Sponsorship gives you a space at the fair, your name and logo on the posters, and your name and logo and link to your webpage on our website, and your name mentioned from main stage during the day.

Non-profit groups

\$25 if you pre-register by August 25, \$35 after August 25.

Businesses and for-profit groups

\$50 if you pre-register by August 25, \$75 after August 25.

If you are planning to sell food, you need to know a lot more information, and supply us with more information as well. See website.

Exhibitors at the fair need to emphasize how they promote peace and social justice. If you are a religious group, your materials should reflect how you work for or what you believe about peace and social justice.

PLEASE CHECK OFF THAT YOU UNDERSTAND THE PARK RULES BELOW!

We want everyone to have a good experience in loading & unloading, and know that if we all drive in the same direction we won't have a traffic jam. Here are the rules so driving in & out of the park goes smoothly.

_____ Yes, we realize we are not to drive on the grass EVER.

Yes, we will not drive stakes into the ground, and could use water-filled milk jugs to hold awning legs.

_____ Yes, we realize we will not be supplied with a table, chairs or awning and should bring our own.

(This keeps prices down!)

_____ **Yes, we will tell all people of our group the rules.**

_____ **We realize that placement of our exhibit space is first come, first served, that there are no assigned locations of exhibit spaces.**

_____ We realize we should drive our car in from the north, and check in with registrar at entrance.

_____ We understand that we will turn left, or clockwise, around the loop at the park.

_____ We will park temporarily on the right to unload, and leave space for traffic to pass on the left.

_____ As soon as we have unloaded, we will exit via the left lane of the north park entrance

_____ We understand there will be no political parties at the fair, and no campaigning for a candidate or proselytizing for a religion.
